

**TOWN OF KNOWLTON, MARATHON COUNTY  
TRAFFIC ORDINANCE # 3-2007**

**RE: Designation of location of STOP Signs**

Section 1: AUTHORITY. The Town Board of the Town of Knowlton has the specific statutory authority, powers and duties, pursuant to State Statute 349.065 and by its adoption of village powers under Sec. 60.10 to regulate, control, prevent and enforce against in the Town of Knowlton certain uses, activities, businesses and operations by persons that may affect the traffic in the Town of Knowlton.

Section 2: POLICY. In the interests of public safety a stop sign shall be installed at the following location to control traffic on the highways over which the Town of Knowlton has exclusive jurisdiction:

At the northwest corner of the intersection of Iris Lane  
with Seagull Drive for traffic on Iris Lane entering Seagull  
Lane.

Section 3: CONFLICTING RESOLUTIONS AND ORDINANCES. All ordinances and resolutions or parts of ordinances and resolutions adopted by the Town Board of the Town of Knowlton in explicit conflict with the terms of this ordinance are hereby repealed.

Section 4: ENFORCEMENT. Violators will be subject to the laws and fines set down by the County of Marathon and the State of Wisconsin law enforcement authorities.

Section 5: EFFECTIVE DATE. This ordinance shall be in full force and effect after its' adoption, publication and installation of above said sign.


On Landing Road at the intersection of Landing Road and Blackberry Lane.
