TOWN OF KNOWLTON, MARATHON COUNTY, WISCONSIN ORDINANCE NO. 12 AN ORDINANCE TO ESTABLISH SPEED ZONES ON TOWN ROADS

The Town Board of the Town of Knowlton, do ordain as follows:

<u>Section 1</u>. A traffic and engineering investigation having been made on the following described highway, the maximum permissible speed at which vehicles may be operated on said highways which speed is herewith established as reasonable and safe pursuant to Section 349.11, Wisconsin Statutes, shall be as set forth herein, subject to approval by the Wisconsin Division of Highways and upon the erection of standard signs giving notice thereof.

The speed limit for all vehicles on the following described portion of town roads in the Town of Knowlton, Marathon County, shall be 35 miles per hour.

- (a) <u>DuBay Drive</u>, from its intersection with State Trunk Highway 34, easterly and southerly to its terminus, a distance of 1.94 miles.
- (b) <u>Johns Lane</u>, from its intersection with State Trunk Highway 34, easterly to its intersection with DuBay Drive
- (c) <u>Old Dancy Road</u>, from its intersection with County Trunk Highway "C", northerly to its terminus, a distance of 0.60 of a mile.
- <u>Section 2</u>. Any person violating any provision of this ordinance may be required to forfeit not less than \$20 nor more than \$200.

- 1) east side of Iris Lane from south of mailbox (1582 Iris) to Feit Road
- 2) west side of Iris Lane from County DB to Feit Road

Violators will be subject to the laws and fines set down by the County of Marathon and the State of Wisconsin law enforcement authorities.
